## Terms and Conditions (3/4)

1. Any extension of credit by BBD Performance Inc. shall be made solely upon the terms, conditions and policies contained herein or published by BBD Performance Inc. from time to time. BBD Performance Inc reserves the right, in its sole discretion, to refuse to extend credit at any time or not to honor any order prior to delivery thereof.
2. The undersigned agrees to pay any and all invoices from BBD Performance Inc its successors and assigns, according to the respective terms of sale of each such invoice.
3. In the event that any invoice or other debt is not paid in accordance with the terms of the invoice, an interest charge equal to 1.25% per month (15% per annum) will be applied to the past-due amount. In addition, the undersigned agrees to pay all collection costs and expenses, including reasonable attorney's fees, incurred by BBD Performance Inc All payments received by BBD Performance Inc on past-due accounts shall be first applied to interest, collection costs and expenses, and then to reduce any outstanding balance due.
4. Any returned check, NSF or stop payment will be subject to a \$50.00 processing fee or 10% of the check amount, whichever is greater.
5. In the event a credit or debit card is used to pay an outstanding balance due to BBD Performance Inc a 3% processing fee will be charged to the amount of the payment. This does not apply to purchases made with a credit card or debit card at the time of sale.

## **Minimum Advertised Price Policy (MAP)**

If not complied with, **BBD Performance Inc.** will cease supplying product to any dealer (or to any distributor who sells to a dealer who advertises the product) whose advertising of the product fails to display a price equal to or greater than the MAP for the product as specified on the current **BBD Performance** pricing list. This policy applies to all forms of dealer advertising including, but not limited to: mailings, catalogs, displays at consumer exhibitions or shows, any and all other forms of advertising media, including, without limitation, the Internet and any other electronic network. Any price information relating to **BBD Performance** products on an Internet website which can be accessed directly through any hypertext link or by any other method which uses the hypertext transfer protocol (http) is considered to be advertising for purposes of this policy. Electronic mail sent in direct response to a customer inquiry is considered to be advertising. Furthermore, this policy applies equally to all **BBD Performance** distributors and dealers. The foregoing is a statement of **BBD Performance Inc's** unilateral policy and expresses the terms upon which we will deal with our customers. **BBD Performance** may modify this policy at any time, as **BBD Performance** feels is necessary. **BBD Performance Inc.** does not seek, nor will it accept, any agreement or understanding with respect to the prices you may advertise or charge at any time.
